**Update to Notice of Administrative Decision to Use
Trust Funds for Trust Land Acquisition**

On September 6, 2013 notice was given of the Trust's Administrative decision to use principal funds for the acquisition of a building. The notice contained an erroneous date by which comments must be received. The correct date is September 20, 2013 and is listed below as well.

Notice is hereby given that on September 4, 2013, the Alaska Mental Health Trust Authority (AMHTA) Board of Trustees (Board) made an Administrative Decision to use \$17,630,000 of principal funds from the Trust Authority Development Account to form and fund a single purpose entity for the purpose of acquiring, owning and managing a 52,500 square foot office building in the state of Washington.

The basis for the Board's determination is explained in a project recommendation prepared by the Trust Land Office (TLO) and presented to the AMHTA Resource Management Committee and Finance Committee on September 4, 2013, in the Resource Management and Finance Committees' motions to recommend the project to the Board, and in the Board's action, memorialized in the Record of Administrative Decision to Use Trust Funds for Trust Land Acquisition dated September 4, 2013.

Persons who believe that the Administrative Decision of the Board should be altered because it is not in the interest of the Trust or its beneficiaries must provide written comments on or before 4:00 PM, Friday, September 20, 2013. Comments should be submitted to the Trust Land Office, 2600 Cordova Street, Suite 100, Anchorage, AK, 99503, or at www.mhtrustland.org.

Following the comment deadline, the Board will consider timely comments that question the decision on the basis of the interest of the Alaska Mental Health Trust and its beneficiaries, and the Administrative Decision may be changed in response to such written comments or other information. Commenting parties will be provided a copy of the final Administrative Decision after the end of the notice period.

To be eligible to file for reconsideration of the Administrative Decision, or to file a subsequent appeal to the Superior Court, a person must have submitted written comments during the notice period.

Copies of the project recommendation and the Record of Administrative Decision to Use Trust Funds for Trust Land Acquisition are available at the Trust Land Office as noted above. If you have any questions concerning this action, please contact the Trust Land Office at (907) 269-8658.
